### Infrastructure Capital Improvement Plan 2019-2023 (ICIP)

The City of Sunland Park, will host five public hearings and two more City Council meetings to provide information on the Infrastructure Capital Improvement Plan (ICIP) 2019-2023. ICIP is a plan that establishes planning priorities for anticipated capital projects.

The state-coordinated ICIP process encourages entities to plan for the development of capital improvements so that they do not find themselves in emergency situations, but can plan for, fund, and develop infrastructure at a pace that sustains their activities.

- The City will solicit input from the public regarding the projects listed on the program, which would most benefit the community.
