

INTRODUCTION-WHO MUST REGISTER

A BUSINESS?

START WITH THE STATE

o Anyone who engages in business in New Mexico must register with the Taxation and Revenue Department.

o "Engaging in business" means carrying on or causing to be carried on any activity with the purpose of direct or indirect benefit.

o All Corporations, LLCs, and Partnerships must first register with the Secretary of State. You can register LLCs online, but partnerships and corporations registration forms must be completed and submitted via mail or in person. For More Information Go Here:


NEXT LOOK AT THE REQUIREMENTS FOR THE CITY OF SUNLAND PARK

o All businesses operating from a physical office location within the City of Sunland Park city limits are required to have a business registration

o Mobile food vendors, security and alarm firms, and any door-to-door activity conducted inside city limits do require a license, regardless of the office location Business conducted

o Business conducted as an independent contractor under a booth rental agreement does require a license

o Business conducted in the home must also register a business to obtain a business/license




STANDARD REQUIREMENTS

- Copy of Current New Mexico State License
- Business Holder / Owner is responsible for meeting all state and federal laws.

 - All employees must obtain a Food Handlers Card.

WHEN AM I READY TO REGISTER MY BUSINESS TO RECEIVE A LICENSE?

- 1. ALL STATE REQUIREMENTS ARE RESEARCHED and met.
- NEW BUILDING -When you have obtained clearance from community development (CD) [SUP, ZONE, CID]
- NEW PLUMBING/ELECTRICAL- when you have obtained clearance from CD [SUP, ZONE, CID]
- 4. CANNABIS when you have obtained clearance from CD [SUP, ZONE, CID]
- 5. MOVING INTO AN EXISTING BUILDING, NO CHANGES -
- 6. When you are renewing your business license and there are no changes to your business

HOME BASED BUSINESS

Some home based businesses will need fire inspection and review from community development.

Request a business application and start there.


SUMMARY

All businesses shall connect with State requirements prior to pursuing a business application for license and registration-including but not limited to daycares, food industry, medical facilities.

Businesses must start the process through community development if they are a new building project or remodeling an existing location.

Cannabis needs to speak with community development for their process on the special use permit and build outs.

All State processes must be completed before engaging the COSP business license and registration.
